STORAGE AND DISPOSAL

Store in the closed original container in a dry, well-ventilated area, as cool as possible, out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seed and fertilisers. Single rinse before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. Puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500 mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS

Poisonous if absorbed by skin contact or inhaled or swallowed. May irritate the nose and throat and will irritate the eyes. Avoid contact with eyes and skin. Do not inhale dust or spray mist. When

opening the container and preparing product for use wear cotton overalls, over normal clothing, buttoned to neck and wrist and a washable hat, elbow length chemical resistant gloves, goggles and half facepiece respirator with dust cartridge or canister. If applying by boomspray equipment wear cotton overalls buttoned to neck and wrist (or equivalent clothing) and elbow length chemical resistant gloves. If applying by low pressure hand wand or high pressure hand wand wear cotton overalls, over normal clothing, buttoned to neck and wrist and a washable hat, elbow length chemical resistant gloves, goggles and a half face piece respirator with dust cartridge or canister. If clothing becomes contaminated with product or wet with spray, remove clothing immediately. If product or spray on skin, immediately wash area with soap and water. If product or spray in eyes wash it out immediately with water. Wash hands after use. After each day's use, wash gloves, goggles, respirator (if rubber wash with

detergent and warm water) and contaminated clothing. **FIRST AID**

If swallowed, splashed on skin or in eyes, or inhaled, contact a Poisons Information Centre (Phone Australia 13 11 26) or a doctor at once. Remove any contaminated clothing and wash skin thoroughly. If swallowed activated charcoal may be advised. Give atropine if instructed.

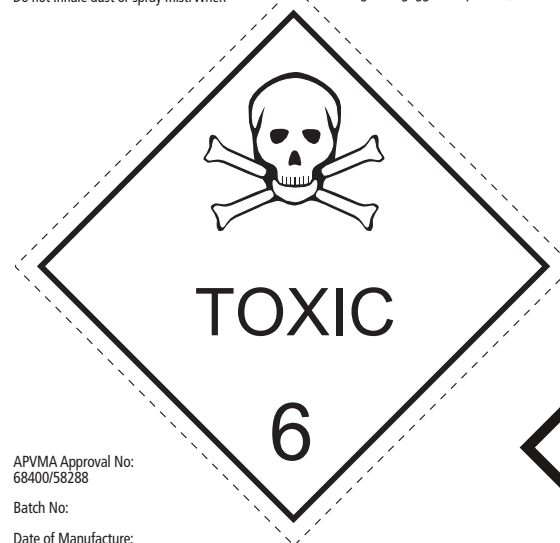
